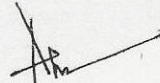
Conditions:

1. Terms and conditions as mentioned in the recognition letter of NCTE Ref. No. ERC/7-106(1s).4.4/2010/3838(1) dated 30-04-2010 of the NCTE be complied with.

2. The college must admit students strictly on merit basis.
3. The college authorities should abide by the provisions of the C.U. First Statutes, 1979 as existing, proposed and as will be amended from time to time in regard to self-financing colleges/institutions and also existing regulations, notifications and orders or as may be promulgated from time to time by the University or the Government of West Bengal in the case of the college.
4. The fund along with fixed deposits of at least at the amount of Rupees Five (5) Lakhs be transferred to the account of the College Governing Body and Rupees three (3) lakhs be kept as fixed as Fixed Deposit.
5. Laboratories for Life Science, ~~Physical Sci~~ and Geography should be well-maintained in the college premises without contravening N.C.T.E. norms.
6. All the payments, viz, salary etc. be made by ^{also Payee} cheque towards the teaching staff of the college as required by NCTE.
